# Global

---

**US intelligence and security agencies have warned that the cyber attack on the government and companies revealed at the weekend was “*ongoing.*”**

- A WHO team set up to investigate the **origins of the coronavirus pandemic** will go to China in January, amid criticism from the US over the probe’s scope and transparency.
- Pfizer Inc delivered the results of the Phase 3 **clinical trial** for its COVID-19 vaccine to Brazilian health regulator Anvisa.
- **The World Economic Forum’s Global Competitiveness Report** concludes that countries with advanced digital economies and digital skills, robust social safety nets and previous experience dealing with epidemics have better managed the impact of the pandemic on their economies and citizens.”

# COVID-19 Vaccine

---

**Saudi Arabia began administering the Pfizer-BioNTech vaccine Thursday, as part of an initial stage of vaccinations that will include people who are older than 65, obese or immunodeficient.**

- **Brazil's** federal government will purchase 46 million doses of the CoronaVac vaccine being developed by China's Sinovac Biotech Ltd.
- **Germany** will roll out the Pfizer-BioNTech vaccine against COVID-19 on December 27, with priority given to the elderly in care homes.
- The **US** FDA said pharmacists can draw additional doses from vials of the Pfizer-BioNTech coronavirus vaccine, potentially expanding the country's vaccine supply by millions of doses.

# Markets

---

**World stocks scaled new peaks and oil rose on Thursday as investors, buoyed hopes of a US fiscal stimulus and the Federal Reserve's pledge to keep pumping cash into markets.**

- On Thursday, **European stocks** and the euro rallied for the fourth straight session as investors built up positions in riskier assets, anticipating a sharp economic recovery in 2021 backed by wider vaccine rollouts and ultra-easy monetary policy.
- **Asian stocks** also closed up.
- On Wednesday, **US markets** closed mixed.
- **Bitcoin** hit another all-time high after first shattering the \$20,000 level on Wednesday.

# Business

---

**Texas and nine other states sued Google, accusing it of working with Facebook Inc in an unlawful manner that violated antitrust law to boost its already-dominant online advertising business.**

- **Luckin Coffee** Inc has agreed to pay a \$180 million penalty to settle accounting fraud charges for "*intentionally and materially*" overstating its 2019 revenue and understating a net loss.
- Germany will make a 1.5 million euro (\$1.83 million) contribution to **Thyssenkrupp's** planned hydrogen electrolysis plant in Saudi Arabia, the second commitment this month under a broader national strategy to support hydrogen technology.

# Africa

---



- The EU delayed almost €90 million in funds to **Ethiopia** over the Tigray conflict. The money will only be given if the federal government meet the **EU's** conditions.
- **South Africa** missed the December 15 deadline to make a deposit to secure vaccines through the Covax program. On Wednesday, South Africa reported over 10,000 new virus cases, seeing a resurgence in infections.
- At least 17 **Nigerian** students were rescued from Boko Haram and two were killed in the operation.
- The **Democratic Republic of Congo** will impose a curfew and mandatory mask wearing in public spaces to counter a new surge in coronavirus infections.

# Africa

South Africa is experiencing a second wave of coronavirus infections, seeing new caseloads last reported over the summer. The government responded on Monday, closing down beaches on the eastern coast and limiting large public gatherings ahead of the festive season.

# Asia

---


- With new virus cases surging, the **Japanese** capital of Tokyo raised its alert level to the highest of four stages.
- The **US** has warned **Pacific island nations** about security threats posed by a Chinese company's cut-price bid to build an undersea internet cable.
- **Fiji** ordered its entire population to take shelter in the path of what is expected to be the worst storm in its recorded history.
- **New Zealand** will begin to offer free COVID-19 vaccines to its entire population by the middle of next year.
- **Vietnam's** central bank said it will work with **US** authorities to ensure a "harmonious and fair" trade relationship, a day after Washington called Vietnam a currency manipulator.
- **Australian** authorities are scrambling to control the first significant outbreak of Covid-19 in several weeks.
- **Hong Kong** set new climate disclosure rules, requiring financial institutions and listed companies to disclose the financial impact of climate change on their businesses, aligning regulations with global standard. **China** did not participate in December 14-16 meetings with the **US** related to the Military Maritime Consultative Agreement focused on maritime safety, without offering an explanation; the MMCA is partly designed to review any unsafe military incidents that have occurred between US and PLA forces, including in the South China Sea.

# Europe

---



- **Euro zone** annual inflation was negative for a fourth consecutive month in November.
- **Britain and the EU** have moved closer to sealing a new trade deal, but it is still unclear if they would succeed.
- Chancellor Rishi Sunak is planning to extend the **UK's** £68bn coronavirus emergency loan schemes to help support businesses struggling with the combination of further pandemic restrictions and a disruptive end to the Brexit transition.
- **French** President Macron has tested positive for COVID-19 and self-isolates, cancelling Lebanon trip. The **UK** reported the highest daily number of new COVID-19 cases since November 14 after the number of new positive tests rose above 25,282. **Sweden's** king admitted that the Scandinavian country has failed with its coronavirus strategy, which has left it with a far higher death toll from the pandemic than its Nordic neighbors.
- **Turkey** warned it will take reciprocal steps after evaluating **US** sanctions imposed over the acquisition of Russian S-400s.
- President Putin said that **Russia** would ramp up its economic support for **Ukraine's** rebel-controlled eastern Donbass region. According to the World Bank, the Russian economy contracted in the second quarter by 8 per cent, by 3.4 per cent in Q3 and is expected to remain in decline in Q4 amid a resurgence in the pandemic.

# Middle East

---

- The UN Security Council is planning to discuss **Western Sahara**, after the US recognized **Morocco's** sovereignty over the disputed region.
- **Kuwait** has signed a six-year, \$106 million contract with Greek gas grid operator DESFA for the group to operate a liquefied natural gas import terminal in Kuwait.
- Two former **Lebanese** ministers, Ghazi Zaiter and Ali Hassan Khalil, have refused to appear before Lebanon's judicial investigator as part of criminal proceedings following the Beirut explosion.
- The **UAE** will join the Eastern Mediterranean Gas Forum, as an observing state.

# Americas

---

- Tired of months of confinement, Christmas shoppers in **Mexico** City have been crowding stores despite a recent spike in coronavirus cases that has strained hospitals in the capital.
- **Brazil** registered over 70,000 new virus cases, a daily record, bringing the country's total caseload above 7 million as a second wave of infections slams the South American country.
- **Peru's** government told people in the country not to invite friends and family who live outside the home to Christmas and New Year celebrations. Clinical trials of **China's** Sinopharm vaccine resumed, just days after Peruvian authorities suspended the tests to better understand why a volunteer had fallen ill.

# Americas: US

---



- Congress continued to haggle over details of a \$900 billion **COVID-19 aid bill** as a Friday deadline looms. The Federal Reserve vowed to keep funneling cash into financial markets until the US **economic recovery** is secure.
- The nation saw a record number of **coronavirus deaths** yesterday, 3,638. For the third day of over 11,000 **hospitalizations**, some hospital systems to near breaking points, with many scrambling to reconfigure themselves to handle a crush of patients streaming in after holiday gatherings and the arrival of flu season. An Alaskan health worker had a **serious allergic reaction** after getting Pfizer Inc and BioNTech's coronavirus vaccine but is now stable. Secretary of State **Mike Pompeo** is quarantining after being exposed to a person who tested positive.
- **New York** surpassed 800,000 confirmed virus cases. **California** reported a record-breaking 63,000-plus new cases and surpassed 1.7 million confirmed cases.
- **President-elect Biden** is expected to pick Brenda Mallory, current head of a regulatory affairs at the green advocacy group, to lead the White House Council on Environmental Quality.

# Science Under the Scope: Vaccine Approval and Distribution in the UK

***This week the United Kingdom became the first country to begin distribution of the much anticipated Pfizer COVID-19 vaccine.<sup>1</sup> Pfizer's vaccine, along with the Moderna vaccine, which is expected to receive approval soon, was developed using an entirely new technology: mRNA.<sup>2</sup>***

The new and relatively untested nature of the technology has raised several questions about the vaccine's effectiveness in preventing infections and transmission, given that such data was never collected during the clinical trial phase.<sup>3</sup> The data that was collected shows that the vaccine is safe and highly efficacious in preventing symptoms of COVID-19. As vaccine administration begins, however, it is still unknown whether the vaccine prevents a person from becoming infected and shedding the virus. "In the worst-case scenario, you have people walking around feeling fine, but shedding virus everywhere," says virologist Stephen Griffin at the University of Leeds, UK."<sup>4</sup>

Regardless of the vaccine's potential short-comings, its availability is a significant step in the fight against COVID-19 and a great

accomplishment for science. To prepare for its distribution the British government has created vaccine centers at numerous locations across the country including stadiums, libraries, and parking lots.<sup>5</sup> They have also been said to have enlisted military planners to help coordinate the logistics and they are hoping to distribute tens of millions of vaccines to people throughout the next few months.

In order to accommodate such large scale distribution, the UK has chosen 50 hospitals as vaccine hubs<sup>6</sup> and is training tens of thousands of workers in vaccine administration.<sup>7</sup> The largest remaining logistical challenges are determining how to divide up the doses into smaller amount and get them to nursing homes -- something the country has still not figured out how to do -- and making sure there is enough dry ice to keep the operation running smoothly.

# Science Under the Scope: Vaccine Approval and Distribution in the UK

The UK's distribution plan prioritizes individuals living in nursing homes<sup>8</sup> and the individuals who care for them.<sup>9</sup> Next in line are those over the age of 80 and frontline healthcare workers. From there vaccine administration is mostly prioritized by age. Level three is all those over the age of 75. Level four is all those over the age of 70 and clinically extremely vulnerable individuals. Level five is those 65 and older. Level six is all individuals aged 16 years to 64 years with underlying health conditions that put them at high risk. Level seven is individuals 60 and older. Level eight is individuals 55 and older and level nine is individuals 50 and older. It is assumed that distribution by age in the UK will continue until all are vaccinated.

The distribution prioritization in the UK differs from what the CDC has described for the United States, which prioritizes those living in nursing homes and healthcare workers first, followed by essential workers and school staff, and then individuals 65 and older and those at high risk due to underlying conditions.<sup>10</sup> Following these three groups<sup>11</sup> the US then prioritizes individuals who work in schools, transportation and housing facilities, followed by children and young adults. The last group that will receive vaccines is everyone else that does not fall into any of the aforementioned categories. It is important

to note, however that the Pfizer vaccine has not yet received emergency use authorization in the United States.

As the UK moves forward with vaccine distribution, they still face a number of logistical challenges in disseminating and administering the vaccine. One large concern put forth by Europol and Interpol is the threat from organized crime groups. Both organizations have warned that criminal groups might target trucks carrying the vaccine and either steal the vaccine or hijack it in return for concessions from the government. They have also noted that the Pfizer vaccine is especially vulnerable to sabotage because of its cold storage requirements. There are further concerns that either state actors or terrorist groups may attempt to disrupt the distribution of the vaccine.<sup>12</sup> Such concerns stem from IMB's announcement that they have suffered a series of cyberattacks that were aimed at getting information on vaccine distribution plans.

Despite these concerns and the logistical obstacles that are yet to be overcome, the first week of vaccine administration in the UK has gone smoothly. If everything continues to move along as planned, 400,000 people will be vaccinated during this first phase.



# Charts in Focus: Europe's Second Wave






# Confirmed Cases (New)


# Total Deaths (New)
