# Global

---

**Overnight, confirmed coronavirus cases rose to 68,657,356 in 217 countries and territories, with 1,565,254 deaths.**

- Roche's chief executive said that supply of **COVID-19 tests** will not meet demand for months to come.
- Some of the **troublesome symptoms** of Covid-19 could last more than six weeks, even in healthy patients, including fatigue, loss of smell or taste, shortness of breath, or a cough, according to a Swiss study.
- The world's wealthy will need to reduce their **carbon footprints** by a factor of 30 to help put the planet on a path to curb the ever-worsening impacts of climate change, according to new findings published Wednesday by the UN Environment Program.
- UN secretary-general Guterres called on countries to donate to the world body's Central Emergency Fund, as the **humanitarian crisis** organization had raised less than half its target.

# COVID-19 Vaccine

---

## The UK medical regulator has advised that individuals with a significant history of allergies should not receive the Pfizer/BioNTech coronavirus vaccine.

- AstraZeneca and Oxford University became the first vaccine developers to publish their trial results in full in the peer-reviewed Lancet journal; scientists say it suggests the need for more trials, but the vaccine showed **overall efficacy** around 70 percent and strong safety results.
- **UK** Health Secretary Hancock said that the number of vaccination hubs in hospitals will be expanded in coming days.
- The **UAE** launched Phase 3 clinical trials for Russia's Sputnik V vaccine, while authorizing use of the Sinopharm vaccine, which has 86 percent efficacy according to 3rd stage trials conducted in the Emirates.
- The **US** government is reportedly in talks with Pfizer to procure more vaccine doses.
- **India's** health secretary said the government could grant vaccine approval within the next few weeks to at least one of the candidates which has applied.
- The **Mexican** government announce plans to begin vaccinations by the third week of December and seeks to vaccinate 125,000 people by the end of the year.
- **Israel** received its first shipment of Pfizer-BioNTech coronavirus vaccine Wednesday, with up to 4 million doses expected by the end of the month.
- Switzerland's Roche is teaming up with US biotech group Moderna to offer antibody tests to help assess if and when someone needs **revaccination** to protect them from coronavirus. People given the US-made Moderna Covid-19 vaccine candidates still had high levels of potent antibodies against the coronavirus four months.

# Markets

---

## S&P Global said US companies are sitting on record amounts of cash to buffer COVID-19 shocks.

- **European shares** hit February highs on Wednesday, joining a global rally on optimism around progress in COVID-19 vaccines and U.S. stimulus package.
- **Asia-Pacific stocks** rose following a record high on Wall Street as investors awaited progress on a US stimulus package.
- **Oil prices** rose on Wednesday as news about COVID-19 vaccines lifted investor hopes for a recovery in fuel demand.
- **US stocks** closed higher Tuesday, with the S&P 500 and Nasdaq closing at new records.
- **Greek stocks** rose and were on course for their 14th straight day of gains, their longest winning streak ever.
- Portugal's 10-year government bond yield fell below zero, adding Portugal to a select group of **negative rates** European countries including Germany and the Netherlands.

# Business

---

## Bipartisan US lawmakers sent letters to Intel and Nvidia seeking information on how their technology was allegedly used to aid Chinese mass surveillance in Xinjiang.

- **Thor Industries**, known for its Airstream trailers, expects a continued sales boom into 2021 as RV demand continues.
- **Boeing** delivered its first 737MAX jets since the FAA ended their grounding.
- **Apple** announced plans to sell their own over-ear AirPods-branded headphones.
- Some **McDonalds** franchises will end a longstanding rebate on Happy Meals and raise some fees.
- **American Airlines** said it would expand its preflight testing system for passengers going to all states with travel restrictions.
- **Tesla** said it plans to raise up to \$5 billion through new stock sales.
- **FireEye**, one of the largest cybersecurity companies in the US, said that it had been hacked, likely by a government, and that an arsenal of hacking tools used to test the defenses of its clients had been stolen.
- Canadian oil producer **Whitecap Resources Inc** has agreed to buy rival **TORC Oil & Gas Ltd** in an all-stock deal valued at about C\$552 million (\$430.81 million).
- **Robinhood** has picked **Goldman Sachs** to lead preparations for its IPO.

# Africa

---

- One week after reaching an agreement with the government in Addis Ababa, humanitarian organizations say they are still not able to access the embattled **Ethiopian** region of Tigray to deliver aid; Prime Minister Ahmed said that Ethiopian forces had shot at a UN team after they ignored instructions and drove through government checkpoints.
- The African CDC called on **African** countries to adopt stricter virus control measures and plan for vaccine distribution.
- **Tanzanian** President Magafuli announced his new cabinet after recent elections, featuring mostly returnees and establishing a new ministry of communications and information technology.
- The two leading candidates in **Ghana's** presidential election have both said they are confident of victory based on their own tallies as the announcement of official results is delayed.
- The **US** placed **Nigeria** for the first time on a religious freedom list of “Countries of Particular Concern,” pressing an ally as Christian groups voice growing insecurity.

# Asia

---

- **Singapore** Changi Airport is posturing to become the vaccine distribution hub for Southeast Asia by investing in cold storage and a task force to oversee the project.
- **China** summoned a **US** diplomat in Beijing to formally protest recent US sanctions against top Chinese lawmakers involved in the implementation of the national security law in **Hong Kong**. China's consumer-price index in November was down 0.5 percent from a year earlier, the first negative reading since October 2009. A senior Chinese economist called for more tolerance and freedom for Chinese academics if the country wants to become an "*ideological powerhouse*." Biden Administration NSA Jake Sullivan said he was "*deeply concerned*" about continuing arrests of pro-democracy activists in Hong Kong after further arrests on Tuesday.
- **Japan's** Ministry of Health, Labor and Welfare will pay up to \$380 monthly to companies that employ persons put out of work by the pandemic. Japan's Prime Minister Suga said the country's latest stimulus package may boost GDP by 3.6 percent. Japan's government bond issuance is expected to reach a record of over \$960 billion in the current fiscal year.





- **UK** Prime Minister Johnson is in Brussels today for last-ditch negotiations to reach a **Brexit** agreement.
- In the UK, Scotland cancelled 2021 secondary school exams, saying teacher assessments will be used instead. Latest figures bring England's COVID-19 second wave death toll to 13,000.
- One of the leading contenders to lead **Germany's** Christian Democrats said he is concerned the planned online leadership election could be compromised by hackers.
- A **Russian** citizen residing in **Denmark** has been charged with espionage on suspicion of having provided information about Danish energy technology to the Russian intelligence service; Russia called the charges a "*mistake*."
- Prosecutors in the graft trial of **French** ex-president Nicolas Sarkozy on Tuesday called for him to be sentenced to a prison term of four years of which he should serve two.

# Europe

Germany was relatively successful in managing the first wave of coronavirus infections that swept through Europe in March but has been less successful in handling the second wave. German Chancellor Merkel warned that Germany may not “*get through winter*” without stricter measures. Over the past seven days, Germany has averaged about 20,000 new cases daily. Yesterday, Berlin reported nearly 600 virus deaths, bringing the total death toll over 20,000.



# Middle East

- The death toll in anti-government protests in **Iraq's** Kurdistan rose to 6.
- The **US** imposed terrorism-related sanctions on **Iran's** envoy to the Houthis in **Yemen**.
- **Morocco** said that the COVID-19 vaccine would be free to its citizens and will mostly rely on the Chinese Sinopharm vaccine.
- Thousands of striking **Tunisian** medics and hospital staff staged a protest after a doctor died due to unsafe hospital construction.
- A visiting **EU** delegation promised to help Palestinians in Gaza secure vaccine doses; confirmed cases in the **West Bank and Gaza** surpassed 100,000.
- **French** officials are reportedly mediating negotiations between the **Lebanese** leaders Hariri and Aoun to form a government in the near future. Lebanon's caretaker government agreed Tuesday that subsidies on bread and essential medicines must be kept.
- A UN analysis of photos of four anti-tank guided missiles in **Libya** found that one "had characteristics consistent with the **Iranian**-produced Dehlavieh" missile.

# Americas


- **Guatemala's** chief COVID-19 official is leaving the position to return to his old job at the University of Colorado.
- **Argentina** surpassed 40,000 deaths.
- **Cuba** said it has attracted \$1.9 billion in foreign investment this year despite tighter US sanctions.
- **Brazil** recorded its first possible case of a rare and potentially fatal fungus called Candida Auris.
- The **US and Ecuador** signed a protocol on trade rules and transparency; US officials said more work is needed to reach a full trade agreement.
- **Mexican** President Lopez Obrador said he wants new legislation to tighten restrictions on “*foreign agents*” to be approved this year. President Lopez Obrador is expected to congratulate President-elect Biden on his victory next week, as one of the final major world leaders to do so.
- Cryptocurrency is emerging as a leading new method for **Latin American** crime cartels to launder money.
- **Canadian** province of Alberta is closing restaurants, bars, gyms and salons as well as limit religious services attendance from Sunday as a coronavirus surge threatened to overwhelm its healthcare system.

# Americas: US

---



- Republican leaders called for Congress to postpone controversial legislation on business liability shields and state and local funding to pass **stimulus funding**; the White House reportedly asked for \$600 stimulus payments to be included. Nearly 1 in 5 restaurants have closed amid the pandemic.
- The US surpassed **15 million cases**, again reporting more than 200,000 new cases and over 2,500 deaths yesterday. At least 1 in 22 people in the nation have contracted the virus. The FDA released an initial announcement calling the Pfizer vaccine “*safe and effective*,” paving the way for **emergency authorization** as soon as this weekend. President Trump urged the FDA to approve the vaccine within days. President-elect Biden outlined a **three-point plan** to curb the coronavirus in his first 100 days as president, including a partial mask mandate, 100 million vaccines, and keeping schools open. A White House coronavirus task force said that the vaccine would not alter the trajectory of the pandemic in the US until late spring. A **new poll from Gallup** shows 63 percent of Americans willing to take the vaccine, up from a September low of 50 percent.
- **Massachusetts** ordered new restrictions on indoor gatherings and a rollback of economic reopening. **Arizona** set another record with over 12,000 daily cases. **Ohio** cleared a 13,000 backlog of positive tests, while still hitting a record high for new cases. Ohio surpassed 500,000 and **Illinois** 800,000 confirmed cases.
- The US Supreme Court rejected a Republican effort to throw out up to 2.5 million mail-in ballots in Pennsylvania as they try to undo President Donald Trump’s election loss. The Nevada Supreme Court also rejected an appeal from the Trump campaign to overturn the **election results**.
- The Army announced the firing or suspension of 14 senior soldiers and commanders in **an investigation** into sexual assault and harassment protection prompted by the murder of Spc. Vanessa Guillen.

# Vaccines in the Workplace

*This week saw a milestone in the fight against COVID-19, as the UK began administering its first non-trial vaccine doses, marking the beginning of the end of this unprecedented global health crisis. More nations in Europe, North America and beyond will soon follow the UK and begin vaccination campaigns, while others like Russia and China have already begun widespread inoculations with their own vaccines. All will be faced with the important question: What role in the vaccine rollout should employers play?*

While healthcare workers and high-risk groups will be the first to receive vaccines in coming months, employers could help ensure widespread vaccination once vaccines become more widely available. Moreover, as companies seek to reopen offices and ensure the safety of workers, clients, and customers, it is also in the interests of employers to pursue high levels of immunization.

However, barriers remain, from high levels of mistrust in COVID-19 vaccines to uncertain legal groundwork for a vaccine that only holds an emergency use authorization.

## *Can Employers Mandate Vaccines?*

In the United States, private employers usually have significant legal freedom in enacting policy like a vaccine mandate. At present, however, most employers are unlikely to require employee vaccination. The unprecedented levels of mistrust and conspiracy surrounding the COVID-19 vaccine, along with the safety concerns that surround any new or quickly developed vaccine, virtually ensure that employers would face backlash for requiring inoculation. Though infectious disease experts have found that vaccination rates increase when vaccines are mandated, top medical authorities – including the WHO – have stated that persuading people to take the vaccine is better than requiring it, and US officials including Dr. Fauci and President-elect Joe Biden have indicated that a mandate at the government level will not be pursued. Moreover, employers are still awaiting

specific guidance on COVID-19 vaccinations from employment agencies like the Equal Employment Opportunity Commission (EEOC) and the Occupational Safety and Health Administration (OSHA), as well as the CDC. While OSHA has stated that employers can legally require flu vaccinations, the fact that any COVID-19 vaccine will be available under “emergency use authorization” from the FDA (rather than full FDA approval, at least in the short-term) puts COVID-19 mandates in uncharted territory. Given the novel legal terrain, some business groups have appealed to federal and local lawmakers to increase vaccine-related protections for employers.

If federal agencies do validate the right of corporations to mandate COVID-19 vaccines, some employers may choose to do so despite likely backlash. Some states and employers already require workers in healthcare and long-term care facilities to be vaccinated against the flu and other preventable diseases, setting a precedent for potential COVID-19 vaccine requirements. Some healthcare employers have confirmed this intention; speaking to NPR, the Dean of Clinical Affairs at Baylor

College of Medicine in Houston said the college plans to impose a COVID-19 vaccine mandate – but only after seeing further evidence of the vaccine’s safety. Other industries more likely to consider vaccine mandates include those where workers operate in high-risk settings like crowded bars or meatpacking plants. The head of the American Federation of Teachers said in September that she supports the idea of requiring FDA-approved COVID-19 vaccinations for teachers, just as many vaccines have in the past been required for students. For the moment, however, even high-risk workplaces have been hesitant to announce plans for vaccine mandates. For example, Smithfield Foods - a pork producer that faced an OSHA citation for failure to protect workers from a spring outbreak that infected almost 1,300 - aims to offer on-site vaccines but says it does not anticipate an inoculation requirement. Some industry experts predict that the current resistance to vaccine mandates will change: Society for Human Resource Management president Johnny Taylor Jr., for one, expects that more employers will ultimately opt for mandates, as COVID-19 is a major workplace hazard that employers are obliged to address. It also remains

too early to judge if companies may resort to mandates where voluntary inoculation is too low for herd immunity, or once the FDA fully approves COVID-19 vaccines.

## *How Else Can Employers Promote Vaccines?*

While corporate vaccine mandates may be uncommon, at least in the US, employers have a variety of other options to encourage vaccine use among employees. A number of companies have publicly announced they are exploring how to offer vaccinations at the workplace, as many businesses do for the flu vaccine. Ford caught headlines in late November with its order of ultra-cold freezers in which to store Pfizer's vaccine in order to make it available for employees. Target has said it will offer vaccines to employees and customers at its in-store CVS pharmacies. Frozen food manufacturer Bellisio Foods, like Smithfield Foods, has announced it is planning for on-site vaccination options. Many employers have also pledged to make vaccines free for all staff.

Along with ensuring employees have physical access to vaccines, employers can play a central role in spreading vaccine

information and encouraging high participation in vaccination drives. Given the prevalence of misinformation about the COVID-19 vaccine and the politicization of the virus, employers serve as a trusted establishment for sharing information on the pandemic. Polls conducted by both Gallup and Axios/Ipsos have shown higher trust in employers than in local and federal governments for handling and communicating about the pandemic. Through clear communication about the importance of vaccination and sharing information about vaccine safety and efficacy, employers can help promote public health within and beyond the workplace. Some business leaders have advocated for companies to look beyond their own workforces and invest in information campaigns and vaccine accessibility programs directed at the broader public. These calls have resulted in initiatives such as CONVINCED, which brings together governments, NGOs, and businesses around the world to develop audience-specific campaigns promoting COVID-19 vaccination across the world.

Beyond sharing reputable information and communicating on the importance of vaccines, employers can also develop

incentives and programs to encourage high vaccination participation. This could come in the form of simple promotion of the vaccine through posters, social media, and communication from business leadership directly to employees.

As vaccines become available in stages to different age and health-risk groups, employers can share official information about who is eligible for vaccines and where they can be found. Companies can also create incentives for being vaccinated in on-site or off-site clinics through offering rewards or holding interdepartmental contests for the highest percentage of vaccinated employees, or offering discounts on insurance for vaccinated policyholders, as some businesses do for flu shots. Companies that hold a “vaccination day” events can also expand such events to include families. Some employers may also establish conditions for those who refuse to take vaccines or have medical or religious exemptions, such as requiring continued remote work, mask wearing, or social distancing.

## ***Vaccine Mandates Outside of the United States***

Outside of the United States, the likelihood of vaccine mandates, either from employers or governments, varies greatly


across different countries. Though many countries, particularly liberal democracies like the US, are unlikely to pursue vaccine mandates, other governments are expected to take a more assertive approach to ensuring vaccinations both among the general public and specific groups like healthcare workers and medically vulnerable people. Brazil’s most populous Sao Paulo state, for example, has announced that the vaccine will be obligatory for all 45 million residents, a policy that has sparked controversy in the country. International businesses may also be more likely to require vaccinations, both for employees and potentially for customers. Last week, the CEO of Australia’s Qantas Airways announced that once “a safe and effective vaccine becomes readily available,” passengers will be required to provide proof of immunization before boarding international flights. While Qantas is thus far alone in such an announcement, similar measures across high-risk sectors like the travel industry may follow. However, as vaccine supplies remain scarce and regulator authorizations remain preliminary, it will be months before vaccine requirements will truly be put to the test.


# Confirmed Cases (New)


# Total Deaths (New)
