Global

Overnight, confirmed coronavirus cases rose to 44,325,170 in 214 countries and territories, with 1,173,200 deaths.

- A **clinical trial** of Eli Lilly's monoclonal antibody treatment against COVID-19 will stop accepting participants due to low likelihood that the treatment will yield results.
- French drugmaker Sanofi and Britain's GlaxoSmithKline will supply 200 million doses of their COVID-19 candidate **vaccine** to a global inoculation scheme backed by the WHO.
- An Italian study of 402 people who recovered from Covid-19—most of whom had been hospitalized with severe pneumonia—found more than half reported at least one **mental-health issue**. Thirty-one percent reported depression, 28 percent post-traumatic stress disorder and 42 percent anxiety.

Markets

Data from Deloitte shows that Europe's direct lending market shrank in H1 2020.

- On Wednesday, **European stocks** dropped for the third day in a row, knocking the regional benchmark to its lowest level since May, on mounting expectations of new government measures to slow the spread of coronavirus.
- **Asian shares** mostly recovered Wednesday from an early decline on worries about rising numbers of coronavirus infections and Washington's inability to deliver more aid to the economy.
- **US stocks** closed mixed Tuesday as concern over rising coronavirus infections continued to weigh on investors.
- **New orders for non-defense capital goods**, a key gauge of US business investment, accelerated faster than expected in September.

Business

ACI Europe warned that nearly 200 European airports face insolvency in coming months unless there is passenger rebound before the end of the year.

- **LVMH** is in talks to cut the price of its \$16.6bn takeover of **Tiffany**.
- **Caterpillar's** Q3 earnings fell by half as equipment demand remains under pressure from the pandemic.
- **Pfizer's** business is recovering more slowly than expected due to a weak drug market recovery and continued disruption of regular wellness visits.
- US pharmaceuticals group **Merck** reported a 55 percent rise in Q3 net income, driven by sales of its cancer treatment drug.
- **3M** beat Q3 earnings estimates as strong PPE demand continues.
- **Advanced Micro Devices** is set to buy Californian chipmaker **Xilinx** in a \$35bn deal, adding momentum to the consolidation of the semiconductor industry.
- **Raytheon** plans to cut 20,000 jobs this year, up from the previously announced 15,000.
- **Visa's** planned acquisition of fintech firm **Plaid** is facing antitrust scrutiny at the US Justice Department.
- **Japan Airlines** is expected to report a consolidated net loss of \$2.2bn for the year ending in March.
- **Amazon** will hire an additional 100,000 seasonal workers rush.
- **TikTok** plans to hire 3,000 engineers over the next three years as it expands globally.
- **Chevron Corp** will lay off 25 percent of **Noble Energy** employees after the companies' merger.
- London's **Heathrow** airport has lost its title as Europe's busiest airport to **Charles de Gaulle** in Paris as quarantine restrictions hamper the industry's efforts to restart mass travel.

Africa

- A **Nigerian** judge threw out a case against 47 men charged with public displays of homosexuality in a case seen as a test of the country's laws against homosexual relationships.
- An opposition party in Zanzibar, **Tanzania**, said that its presidential candidate has been detained and nine people were shot dead ahead of Wednesday's elections.
- International mediators urged the **Guinean** government to lift a police barricade on the home of the main opposition leader, who contradicted official results of the election and called for protest. Guinean state media reports that 21 have died as a result of post-election violence.
- **Kenya's** parliament is debating a constitutional amendment that would change its presidential system to a hybrid one and create an official role for the opposition leader. Kenya surpassed 50,000 coronavirus cases.

Asia

- In **India**, hundreds of frontline medical workers in Delhi have launched an indefinite strike over months of unpaid salaries.
- 1.6m hopefuls will sit **China's** civil service exam in November, a near-record high number that some analysts say is indicative of concern about the labor market. A disbanded **Hong Kong** pro-democracy organization, Studentlocalism, said that police have arrested a former organizer of the group. Legal experts have drawn reassurance from US advice to financial institutions and the fact that the presidential blacklist of sanctioned officials has not been expanded, saying that international banks operating in Hong Kong face fewer challenges than feared. Xinjiang officials ruled out a link between the earlier Urumqi outbreak and the current Kashgar outbreak.
- Thousands of Muslims gathered in **Bangladesh** to protest **French** President Macron's remarks on cartoons of the Prophet Mohammad.

Europe


- **Spain's** government announced plans to increase social spending and taxes on the rich and big business.
- A group of migrants died attempting to cross the **English Channel**, the deadliest incident since the start of a spike in asylum seeker crossings last year.
- **Spain and Gibraltar** are seeing a last-minute Brexit deal to preserve free movement across their border.
- The **US** urged a diplomatic solution in **Nagorno-Karabakh** as fighting continued into its second month; **Russian** President Putin and **Turkish** President Erdogan discussed the conflict in a phone call Tuesday.
- **France** reported its highest daily death toll since April at 523; France is now being discussed as the new epicenter of Europe's second wave. **Greece** also reported a record single-day rise in cases. COVID-19 deaths in **England** have risen almost five-fold in four weeks. Health officials in **Switzerland** warned that the country could run out of intensive care beds in 11 days, saying that a nationwide lockdown should be on the table. **Poland and the Czech Republic** have posted record daily numbers of coronavirus cases as the spread of infection wreaks more devastation in central Europe. **Belgium** surpassed the **Czech Republic** to have the highest infection rate in the **EU**.

Middle East


- The UN said that nearly 6,000 **Afghan** civilians have been killed or wounded in 2020.
- **Algeria's** president was hospitalized for a specialized treatment.
- **Morocco** surpassed 200,000 virus infections.
- **Iraq** reopened its Sinak bridge in the Baghdad Green Zone bridge, one year after its closure due to violent protests.
- **Saudi Arabia** set new rules allowing foreign pilgrims to visit Mecca after completing a three-day quarantine at their hotels.
- **Israel** will approve the first settler homes in the West Bank town of Hebron since 2002.
- **Iran's** daily cases and deaths hit another record high, despite many localities following new restrictions.
- The minister of youth and sports in **Yemen's** rebel Houthi government was shot and killed in Sanaa, reportedly a result of Houthi infighting. A UN survey found that child malnutrition is at record highs in parts of Yemen.
- The UN **Libya** envoy predicted that a date for elections would be set at the next Geneva meeting.
- The **Pakistan** government is preparing to make it mandatory for all citizens to wear face masks in public.

Americas

- In **Brazil**, a fire in one of Rio de Janeiro's main hospitals forced over 200 people to evacuate, at least one person is reported dead.
- **Venezuelan** opposition politician Leopoldo Lopez pledged to continue fighting for his country from his self-imposed exile in Spain. Venezuela's Juan Guaido accused the government of being responsible for the forced disappearance of a Popular Will Party opposition activist.
- Hurricane Zeta, the 27th named storm of this year's intense Atlantic hurricane season raked across the **Yucatan Peninsula** Tuesday and is on track to hit the **US**, south of New Orleans, Wednesday evening.
- Mexico surpassed 900,000 coronavirus infections.

Americas: US



- **Washington, Oregon and Nevada** joined **California** in promising to independently review any COVID-19 vaccine approved by the federal government. **Pennsylvania** reported a record daily case rise of 2,751 cases. **Wisconsin** again reported record daily cases and deaths. A **Kansas** nursing home where every resident was infected with coronavirus is terminated from Medicare. **New Jersey's** Gov. Murphy called on citizens to cooperate with contact tracers after a study showed that 60 percent of residents contacted by contact tracers refused to provide information.
- A College Board study found that the pandemic dampened **tuition growth rates** to their slowest in decades.
- Vice President Biden **campaigned** in Georgia, a traditionally red state now considered by some a battleground state. The Department of Homeland Security's watchdog body said that officials at its Cybersecurity and Infrastructure Security Agency had not adequately prepared for **potential violence at polling station**. The Supreme Court barred the **counting of ballots** received in Wisconsin after election day. A Reuters/Ipsos poll found that over four in ten supporters of both Trump and Biden would not accept an **election result** of their candidate losing.
- In Pennsylvania, **violence and looting** continued in Philadelphia on Tuesday for a second straight night, as authorities struggled to contain civil unrest sparked by a video showing police fatally shooting Walter Wallace Jr., a Black man who was holding a knife.

Paused Vaccine Trials

Many researchers and reporters have noted that it is not unusual to pause a clinical trial, and some have even argued that the pause is a good thing. A pause can be a good thing because it indicates that companies are not influenced by political pressure and are continuing to take the necessary safety precautions.

Last month, the COVID-19 vaccine being developed by AstraZeneca was placed on hold due to an adverse effect among one of the study participants in Great Britain(1). An adverse reaction is defined as “an unwanted or harmful reaction experienced following the administration of a drug or combination of drugs under normal conditions of use.” (2) In other words, an adverse reaction to a vaccine is a serious event that occurs as a result of taking that vaccine. In the case of the AstraZeneca trial, the individual in question developed a serious spinal cord problem(3). Since the initial hold, the AstraZeneca trial has continued in many countries, but remains on hold in the United States (4).

This month two additional trials -- one for a vaccine and one for a treatment -- were paused as a result of adverse effects. The vaccine trial, directed by Johnson & Johnson, was paused as a result of an unexplained illness in a patient(6). The company was quick to point out that there is a significant difference between a trial pause and a trial hold, with the latter being more serious. A trial pause only results in a halt in recruitment and dosing, whereas a trial hold is a requirement based on health concerns from a regulatory body like the Food and Drug Administration (FDA)(7).

Paused Vaccine Trials

Many researchers and reporters have noted that it is not unusual to pause a clinical trial, and some have even argued that the pause is a good thing (8). It is a good thing because it indicates that companies are not influenced by political pressure and are continuing to take the necessary safety precautions. For the Johnson & Johnson study in particular, which is a large-scale study involving more than 60,000 participants (9), it is not at all unusual that the trial has been paused. The difference is that the spotlight that COVID-19 has shown on the vaccine development process has meant that these small, normal setbacks attract national and international attention.

Scholars have acknowledged, however, that the pause of the Eli Lilly treatment clinical trial could be of greater concern than the pause of the Johnson & Johnson vaccine trial(10). This is because the bar for pausing a treatment trial is typically higher than the bar for pausing a vaccine trial. Vaccine trials have a lower bar because they are to be given to billions of healthy people, so even one adverse reaction must be taken seriously. Treatment, however, is given to sick individuals and, therefore,

the adverse reaction is measured against the severity of the illness.

Now that each trial has been paused, a safety board will have to review the patient and study information to determine if the adverse reaction was, indeed, caused by the drug. Oftentimes, this can be difficult to prove definitely and trials can be allowed to move forward as long as they incorporate additional tests(11). In most cases in which a trial is paused, it is eventually allowed to continue. With the case of the COVID-19 vaccine there is an additional need for caution because many of the vaccines are utilizing cutting edge technology, i.e. technologies that have never before been used in vaccine development(12). Thus, scientists have no baseline data on the safety of the technology overall.

As the world moves forward in its race to develop a vaccine for the COVID-19 pandemic, setbacks that would be considered uneventful in normal times, are now front page news. The key thing that the public must understand is that these paused trials

are not unusual and they do not mean that either the Johnson & Johnson or the AstraZeneca vaccine cannot go on to be an approved and efficacious vaccine against the virus. Rather scientists are simply following standard safety procedures for vaccine development.



Region in Charts: Europe

Europe continues experience a second wave that health experts worry could threaten national health systems. Over the past week, coronavirus-related restrictions have tightened, including localized lockdowns and overnight curfews. However, if cases continue to rise, health authorities may push for more stringent measures; Switzerland indicated on Tuesday that a full lockdown should be on the table as intensive care bed fill at an alarming rate. Moreover, a recent UK antibody study casts doubt on the possibility of achieving some level of herd immunity, finding that antibodies fade within months.





Region in Charts: Surging Cases in Europe


The daily death toll in Europe, while increasing, is significantly lower than the first wave.



As of 2100 hours US EDT on October 27


Confirmed Cases (New)


Total Deaths (New)
