Global

Overnight, confirmed coronavirus cases grew to 36,430,705 in 213 countries and territories, with 1,061,153 deaths.

- The **World Economic Forum** postponed its meeting to May 2021 and will take place at Lucerne rather than Davos.
- The World Bank raised its estimate of how many people would be pushed into **extreme poverty** as a result of the coronavirus to 150 million.
- France, the US, and Russia will meet in Geneva today to discuss **Nagorno-Karabakh**.

Markets

Foreign investors have snapped up Chinese debt this year, lured by relatively high yields and the country's strong economic recovery following the coronavirus pandemic.

- **Asia-Pacific equities** rose on Thursday, on hopes for partial economic stimulus from President Trump.
- **European stocks** also resumed gains on Thursday, inching closer to a three-week high.
- The **US stock market** rallied after President Trump reversed his claim that he would cancel stimulus talks until after the election in tweets calling for individual aid and support for airlines and small businesses.
- The ECB's Lagarde said that a **digital euro** remains "*high on the agenda*" for the bank.
- Central banks became net sellers of **gold** in August for the first time in over a year as they seek to free up resources to handle the coronavirus crisis.
- New York Fed leader Williams said that **bond** buying, one of the central bank's stimulus options, is already at an "*extremely high level.*"

Business


Nearly one in five UK businesses are planning to increase homeworking permanently, a trend seen as a threat to the livelihood of city centers, particularly in London.

- **Ruby Tuesday** filed for Chapter 11 bankruptcy.
- **United Airlines and Cathay Pacific** are trialing an app through which airline passengers can upload and verify negative coronavirus tests.
- **Eli Lilly** is seeking emergency use authorization for its antibody drug for high-risk COVID-19 patients.
- Some US business groups are pushing back against a Trump Administration directive to limit **racial-sensitivity training**.
- Regulators fined **Citigroup** \$400m for falling short in “*various areas of risk management and internal controls.*”
- The US is reportedly exploring restrictions on **China’s Ant Group and Tencent Holdings..**
- Technological glitches at the **Swiss Roche** factory caused delays in the UK’s testing regime.
- All **Nippon Airlines** reportedly proposed staff layoffs as it struggles to handle the pandemic’s fallout.
- The US indicted **six chicken industry** executives over allegations of price-fixing.
- **Imperial Brands** warned that sales of vaping products and other alternatives to cigarettes fell by nearly a third last year, as smokers spent more money on tobacco during the pandemic.
- **Samsung Electronics** said its third-quarter operating profit probably surged by nearly 60 percent, as its smartphone and chip businesses benefited from tougher US sanctions on China’s **Huawei**.

Africa

- **South Africa's** largest trade unions held strikes and marches to protest the severe job destruction in the country amid the pandemic.
- The **Ethiopian** parliament voted to sever all relations with the Tigray state; longstanding tensions between the state and the federal government had come to a head last month when Tigray held an election despite a federal ban on elections due to COVID-19.
- Five were injured in vehicle ambushes in **Mozambique** amid a spike in violent extremism in the country.
- A **Kenyan** court found two men guilty of supporting the Westgate shootings, 2013 attacks on a Nairobi mall that left 67 dead.

Asia


- **Jakarta** is preparing its third COVID-19 cemetery; labor rallies and coming elections add to fears of mounting death tolls.
- **Thailand** is introducing tax incentives to boost domestic consumption.
- Officials and experts say there are signs **India's** outbreak is peaking.
- **Malaysian** PM Yassin tested negative for COVID-19.
- Researchers said a **Chinese** experimental vaccine under development by the Institute of Medical Biology was shown safe in an early-stage trial. Wood Mackenzie estimates that the cost of China's carbon neutral goal could reach \$5tr. The WHO is waiting on Beijing to approve the make-up of an international team to investigate the origins of COVID-19 in China. The wealth of ultrarich Chinese jumped 41 percent between April 2019 and July 2020, helping boost global billionaire wealth to a record high.
- **Singapore** will allow its residents to take round-trip cruises that do not stop in other countries in an effort to restart the industry safely.

Europe

- Top **EU and UK** Brexit negotiators hinted at “cause for optimism” in negotiations.
- The **Turkish** lira again hit a record low against the dollar amid ongoing geopolitical crises.
- A **Greek** court ruled that the neo-Nazi Golden Dawn party is a criminal organization.
- **Spain** set out the goal of creating over 800,000 jobs in the next three years using €72bn of EU funds.
- **Germany and France** are set to jointly propose EU sanctions against Russia over the poisoning of Alexei Navalny.
- **Russia’s** President Putin praised President Trump and criticized Joe Biden’s anti-Russian rhetoric, but said he was reassured by Democratic support for arms-control agreements, in the leaders first substantive comments on the 2020 **US** elections.
- The **UK’s** NHS will establish “*long COVID*” clinics to deal with chronic symptoms of COVID-19 including breathlessness and brain fog. COVID-19 has killed three times more English and Welsh people this year than influenza and pneumonia combined, according to the Office for National Statistics. The UK will shut pubs and restaurants in the north. **Irish** health officials warned that infection rates are rising “*exponentially.*” **Germany’s** federal states agreed to ban overnight visits for domestic travelers from high-risk areas. **Italy** made face masks mandatory nationwide. Former Italian PM Berlusconi recovered from COVID-19. **Poland’s** daily coronavirus cases surged over 40 percent on Thursday compared to the previous day, as infection rates hit a new record. **Austria** surpassed 50,000 confirmed virus cases. **France, Spain, the UK and Russia** again registered new virus cases in excess of 10,000 yesterday.

Middle East

- **Iran** recorded its highest daily death toll on Wednesday.
- PM Netanyahu's wife is accused of violating Israel's home quarantine for a haircut.
- The new **Kuwaiti** emir named Sheikh Meshal, a brother of the late emir and deputy chief of the National Guard, as Crown Prince.
- **France** will hold an aid conference for Lebanon in November.
- **Saudi Arabia** reported that 24,000 pilgrims had performed Umrah since the reopening of the Grand Mosque four days ago, with no cases linked to the gatherings.
- **Tunisia** is considering instituting a curfew to combat the country's second wave.
- An advisor of President Trump said that the **US** would draw down forces in **Afghanistan** to 2,500 in 2021.
- **Qatar** submitted a formal request to the US to purchase F-35 fighter jets.



- Damage to Cancun, **Mexico** from Hurricane Delta was less than feared. Former top Mexican security official Genaro Garcia pleaded not guilty to drug trafficking charges.
- A 5.3 magnitude earthquake that struck in the open ocean was felt in several **Caribbean** islands Wednesday.
- Many months into the pandemic, public health experts believe that **Peru's** bet on cheap antibody tests, which it invested in rather than molecular tests, greatly hurt the country's pandemic response.

Americas

Brazil continues to report high numbers of new cases of coronavirus, with total reported infections now surpassing 5 million. While the spread appears to have peaked, the country continues to report a high death rate. After the US, Brazil has the second highest numbers of deaths due to coronavirus, totaling 148,228 as of yesterday.

Americas: US

- **President Trump's** doctors described him as “*symptom-free*,” and he returned to the Oval Office in the afternoon.
- New **polls** show Biden leading in the battleground states of Pennsylvania, Iowa and Florida. VP Mike Pence and Democratic challenger Kamala Harris clashed over coronavirus handling in a civil **vice-presidential debate**; Harris made history as the first black woman to appear in a presidential-level debate.
- Seven states set new records for **coronavirus hospitalizations** on Tuesday. **Texas** became the second state to surpass 800,00 virus infections; **21 states** reported more than 1,000 new infections. **Florida** became the fifth US state to surpass 15,000 COVID-19 deaths. Protests broke out in Orthodox Jewish areas in **New York** City over renewed virus rules. NFL players on three teams tested positive, endangering this weekend's already postponed games. Saturday Night Live paid audience members \$150 to attend its premiere to comply with New York City rules prohibiting live audiences unless they are cast members.
- White House economic advisor Kudlow said there is a “*low probability*” that Congress will agree with the Trump Administration on limited targeted aid **stimulus package**.
- Vaccine developers face significant difficulties persuading Black participants to join **clinical trials**.
- House panels released reports calling for stringent controls on **tech companies'** power and market share; one Democratic leader called for reversing Facebook's purchase of Instagram.
- Two alleged **ISIL militants** called the “ISIS Beatles” arrived in the US to face charges after prolonged extradition negotiations with the UK.

China Briefing: The Defense Industry and Military Modernization

On September 1, the US Department of Defense released its annual report to Congress on military and security developments in China. The report was attention-grabbing for both its content and the context of heightened great power tension in which it was published. Along with over 100 pages of detailed assessment of China's military capabilities, strategy, technology, and growing global presence, the report situates the importance of the People's Liberation Army (PLA) in the broader domestic and foreign policy goals of the Chinese Communist Party (CCP).

Two decades after the Department of Defense first began issuing this annual report, the state of play for China's military has changed dramatically. 20 years ago, the PLA was sizeable but largely obsolete, reliant on outdated technologies and lacking needed training for efficiencies. However, the rapid development of PLA capabilities over the past two decades has strengthened and modernized the force, and China now seeks to build a "world-class" military by the end of 2049, which many analysts interpret as a military equal or superior to the US or other great powers.

The report taps into several broader trends of the growing integration of China's political strategy, as the CCP's leadership under President Xi takes an increasingly interconnected strategy to achieving foreign policy and economic growth goals. In line with this trend, the PLA is taking a more prominent role in furthering China's

foreign policy goals, and analysts have identified an increasing alignment between defense policy and that of the Ministry of Foreign Affairs, resulting in more synchronized actions and rhetoric. The Department of Defense sees this new integration of goals as a sign of the increasingly global character that China sees in its military power. The PLA is therefore expected to help further China's foreign policy goals, which the report characterizes as a "revisionist" approach to the international order to shape it in the interests of the CCP. China's 2019 defense white paper used language such as the "New Era" of China's national defense and describes the "global significance" of the PLA. Towards this end, China will seek to develop its military relationships with partner across Europe, Africa, Latin America, and the South Pacific, and has expanded defense exchange mechanisms with 17 neighboring countries.

The possibility of increased overseas basing is another key question in China's global power projection, and the report affirms that China is seeking to establish a “*more robust overseas logistics and basing infrastructure*” to allow the PLA to sustain its growing military power at greater distances. Beyond the already established base in Djibouti, the report predicts that Myanmar, Thailand, Singapore, Indonesia, Pakistan, Sri Lanka, the UAE, Kenya, Seychelles, Tanzania, Angola, and Tajikistan are likely places China would consider for building bases.

Along with insights on the PLA's rising importance in Chinese foreign policy, the report provided insight into how China's military strategy is growing more intertwined with economic and development policy as well. Military modernization and economic development support each other through allowing for larger defense budgets, a growing military-industrial base, and the integration of military goals and the PLA in other keystone CCP initiatives, including the Belt and Road Initiative (BRI) and Made in China 2025. Moreover, the report addresses a topic of increasing interest to international China watchers: the Military-Civil Fusion (MCF) Development Strategy, which seeks to “*fuse*” efforts for China's “*national rejuvenation*” goals, tying together military, economic, and social development and

governance. The MCF strategy consists of six interrelated efforts, aimed at fusing the defense industrial base and civilian technology base and maximizing the gains for military and civilian science and technology expertise and infrastructure. The report warns that the MCF means that there is no clear distinction between China's civilian and military economies, increasing the difficulty for international entities engaged with China, particularly in technology, who do not seek to contribute to its military modernization.

Neither the idea of military-civilian integration nor the MCF strategy itself is new to China, having been a growing idea since the early 2000s, initially echoing the cooperation of civilian and defense sectors observed in many other countries, including the US. However, the CCP has renewed interest in MCF over the past few years, elevating its importance and integration in broader national strategies. Beyond heightened focus on the MCF, the increasing importance of the defense industry and integration of military strategy into CCP national agendas can often be seen clearly in the makeup and rhetoric of the party under President Xi. Promotions of party members with defense backgrounds have been frequent, and party regulations and rhetoric often reinforce the importance of President Xi's absolute leadership over the military.


Many other aspects of the lengthy report sparked analytical conversations, from discussion of China's expanding nuclear arsenal to debate over the assertion that China's shipbuilding capacity and capability has already surpassed the US. Perhaps the most immediate questions prompted by the report, however, focused on the likely most dangerous flashpoints for Chinese military action: China's regional territorial claims and most specifically, Taiwan. Many analytical reactions to the report focused on the question of how changing Chinese military capacity may or may not increase the likelihood of use of force against Taiwan, but the report does not provide clear answers. Chad Sbragia, the Deputy Assistant Secretary of Defense for China within the Department of Defense, when asked directly about the implications of the report for Taiwan, indicated that it is less an issue of capacity than of political will, noting that there are certainly situations in which the PLA could use force even without full confidence of military capability. However, Sbragia and other analysts have pointed to the importance of watching China's developing military technology, which may have

critical implications for the regional conflicts that are most important in Chinese foreign policy. As the report explains, 2020 represents a key CCP military transformation milestone, before which the military sought to complete "*mechanization*." The country is now entering a new period in which China plans to pursue, through 2035, a "*modernized*" military force. This modernization phase, while broadly defined, is often described in official rhetoric as focusing on innovation, informatization and technology. Although it will be many more years until a fuller understanding of China's "*modernization*" can be reached, the CCP's clear focus ensures that changing military capabilities will have key implications for both China's wider global power projection and its leverage in high-priority regional disputes.

Selected Chinese Territorial Claims





As of 2100 hours US EDT on October 7


Confirmed Cases (New)


Total Deaths (New)
