#### WHAT WE'RE WATCHING

Four days of protest in Ecuador may end (or intensify) when the final result of the 1st round of the presidential election is announced. Supporters of a popular indigenous candidate and a conservative pro-business candidate are protesting over the yetuncalled vote, which will determine who faces Andrés Arauz, a leftist economist and protégé of the current president, in an April runoff vote.

# Global

# Confirmed coronavirus cases globally surpassed 107.8 million, with deaths at 2.4 million.

- A Human Rights Watch report found that dozens of countries used the coronavirus as a pretense to restrict free speech, including 18 where governments used police forces to assaulted reporters over their coronavirus coverage and 10 where governments used social distancing to disband protests.
- A clinical trial in Britain found that an arthritis drug, tocilizumab, found that the drug reduces the risk of deaths in hospitalized COVID-19 patients.
- Twitter will add more **labels for world leader's** and governments, including for leaders' personal accounts, to give users context.



# **COVID-19 Vaccine**

# The European Commission said it has approved all requests for the export of vaccines, easing concerns on a ban to secure supplies for Europeans first.


- The WHO highlighted "three major threats" to the UN-led international equitable vaccine initiative,
   Covax: a \$27 billion financing gap in the ACT Accelerator that supports the equitable distribution of coronavirus tests, treatments and vaccines globally; respecting Covax contracts and not compete with them; and upscaling manufacturing to increase the volume of vaccines with innovative partnerships to include tech transfer, licensing and "other mechanisms to address production bottlenecks."
- Montenegro and Saint Vincent and the Grenadines have approved Russia's Sputnik V vaccine against the new coronavirus for use, Russia's RDIF sovereign wealth fund.
- Zimbabwe has purchased 600,000 COVID-19 vaccines from China's Sinopharm, in addition to 200,000 China has donated.
- Two million doses of Chinese company CanSino Biologics' vaccine arrived in Mexico.

# **COVID-19 Vaccine**

Globally, 160.07 million have received vaccinations.

Vaccination programs are underway in Chile, Brazil, Argentina and Mexico, even though only a small portion of their populations have received first doses. The region's key challenge will be securing enough doses, as most countries are dependent upon vaccines from the COVAX facility, which is under funded and under supplied. # Markets

A record \$58.1 billion poured into global equity funds over the past week as investors pulled money out of cash funds and had a lighter exposure to bonds, BofA's weekly fund flow data showed on Friday

- European shares fell at the start of trading as investors awaited progress towards more U.S. fiscal stimulus.
- Markets in **China and most of Southeast Asia** are closed on Friday for the Lunar New Year.
- •The S&P 500 and Nasdaq closed at record highs Thursday, following a rocky trading day for US markets.
- **Bitcoin** jumped to a new high after BNY Mellon announced that they had formed a new unit to assist clients with the cryptocurrency.

- US federal prosecutors launched an investigation into potential market manipulation in the case of GameStop and AMC. WallStreetBets is now driving a rise in cannabis stocks.
- Benchmark prices of European carbon permits topped €40 for the first time.
- Global oil and fuel prices are picking up as demand returns to pre-pandemic levels amid easing coronavirus lockdowns in key countries like China and India.

# **Business**

# Australia will next week introduce landmark legislation to force Alphabet's Google and Facebook to pay publishers and broadcasters for content.

- European IPOs mark best start to year since 2015 with investment of €8bn in equity through 16 deals, as extended pandemic lockdowns fuel investor enthusiasm for digital companies.
- Brit, one of the largest insurance companies in the Lloyd's of London market, has predicted that the industry's overall losses from the pandemic will be well above the \$107 billion that was initially forecast.
- **Disney** reported quarterly earnings that topped Wall Street estimates, largely on the strength of online streaming.

- A survey of US workers found that 44 percent do not know when they will return to in-person work, as many companies push office reopening to September or beyond.
- **Polyus**, Russia's biggest gold producer, will power its two biggest mines using hydropower from RusHydro, in a major step towards reducing emissions.
- **Singapore** airlines began operating flights will crews fully vaccinated against COVID-19.
- **Expedia** posted larger-than-expected losses, with Q4 bookings dropping 67 percent.

# Africa

- A surge in Covid-19 deaths across **Africa** is a "*disturbing*" sign that its health systems are dangerously overstretched, the WHO said on Thursday; Africa had experienced a near 40 percent surge in Covid-19 fatalities in the last month.
- Primary schools reopened in Angola after 11 months of COVID-19 restrictions.
- **Namibia** liquidated its national airline, citing longstanding debt and COVID-19 restrictions.
- Human Rights Watch reported that the **Ethiopian** army carried out "*indiscriminate*" shelling of Tigrayan urban areas in November 2020, in conflict with international laws.
- The **Mozambican** military reported that Islamist attacks in the northern Cabo Delgado region, which has been a warzone for months, are dwindling.
- Nigeria's interior minister warned protesters against planned demonstrations at the Lekki gate.



# Asia

- Today is Lunar New Year, beginning the year of the Ox. Southeast Asia's tourism industry is looking to attract domestic tourists for the holidays as foreigners remain barred by COVID-19 restrictions.
- Water levels in the Mekong River have fallen to a "worrying level" in part due to outflow restrictions from Chinese hydropower dams upstream, the Mekong River Commission (MRC) said on Friday, calling on Beijing to share all of its water data.
- **Malaysia's** GDP shrank by 5.6 percent in 2020, with a 3.4 percent contraction in Q4 and ongoing jobs weakness.
- **Australia's** second-most populous state of Victoria will be placed under a five-day lockdown, after a cluster linked to a quarantine hotel in Melbourne emerged. The Australian Open tennis tournament to continue without spectators.
- BBC World News was barred from airing in China, a week after the UK revoked Chinese state media's license in the country.

# Europe

- Mario Draghi is set to become **Italy's** next prime minister with an overwhelming parliamentary majority after an online poll of Five Star Movement voters backed his new coalition.
- Kremlin critic Alexei Navalny returned to court on Friday for a trial on slander charges he calls politically motivated amid mounting tensions between Russia and the West over his jailing.
- **Turkey** will not turn back from its acquisition of Russian S-400 defense systems despite **US** sanctions, while signaling desire to resolve issues with its NATO ally through dialogue.
- France's central bank governor has called for the ECB to "*decarbonize*" its multitrillion-euro holdings of corporate bonds.
- UK small businesses will be offered financial support to handle new post-Brexit regulatory costs of trading with the EU. Britain's coronavirus-ravaged economy slumped by 9.9 percent in 2020, the biggest annual crash in output in more than 300 years.
- Thirteen people have been arrested in **Denmark** in the last week for acquiring firearms and ingredients to make explosives on suspicion of planning a terrorist attack in either Denmark or **Germany**.
- Germany is poised to close its borders with the Czech Republic and at least one region in Austria where authorities say infection rates involving variants first identified in Britain and South Africa are high. Poland surpassed 40,000 coronavirus deaths.

# Middle East

- The Saudi-led coalition reported that they destroyed a Houthi missile and two drones bound for Saudi Arabia from Yemen, days after the Houthis hit civilian aircraft at Abha airport.
- Saudi Arabia and Qatar officially resumed trade through the Abusamra border crossing.
- **Omani** officials said that the country is "*satisfied*" with its current relationship with **Israel**, dispelling speculation that it might be next to normalize relations with Israel.
- The Sudanese government issued a blanket order to prosecute members of the ousted dictator Omar al-Bashir's former party following days of protests by Bashir loyalists.





# Americas


- Medical teams warned that evangelical missionaries are stoking resistance to the vaccine in **Brazil's** remote indigenous villages.
- Venezuelan government officials and opposition leaders have met to discuss buying coronavirus vaccines through the COVAX program using cash frozen in the US by economic sanctions.
- A **US** trade body ruled that **Mexican** blueberry imports are not harming the US market, a win for Mexican farmers. Mexico's central bank unanimously cut rates to 4 percent despite an uptick in inflation.
- Tensions rose in Ecuador as votes were counted to determine who will face Andres Arauz in April's runoff elections; conservative businessman Guillermo Lasso has pulled ahead by some 5,000 votes while indigenous activist Yaku Perez has alleged fraud. As of Thursday, 350,000 ballots had yet to be counted.
- The killings in Mexico of 14 **Guatemalan** migrants, suspected to have been murdered by police, may amount to a "*state crime*," a senior Guatemalan opposition politician.

# Americas

Latin America has experienced an intense second wave of coronavirus infections; the region peaked on January 15 with 156,963 daily new infections. While cases are now declining, the more infectious "Brazil strain" risks a new surge, as vaccine inoculation rates are very low in the region.

# **Americas: US**

- Nationally, 35.4 million people have received one or more vaccine doses. President Biden announced that the US has secured 200 million additional doses of Pfizer and Moderna vaccine, increasing the US short-term supply by 50 percent, enough to cover every American adult by the end of July. Dr. Fauci predicted that it could "open season" on vaccine doses by April, meaning they would be available to the general public. Daily new infections rose back above 100,000. The White House is reportedly discussing domestic travel restrictions to contain the spread of the UK, Brazilian and South African strains.
- Ohio posted a record 751 deaths, reflecting a backlog in recording. Florida topped 1.8 million infections. Washington DC,
  Illinois and North Carolina reported first cases of the South African virus strain.
- Democratic **impeachment** managers wrapped up their arguments Thursday, saying that former President Trump gave clear orders to the capitol mob and remains a threat. Trump's defense team said rioters acted of their own initiative and are expected to rest their case today.
- New weekly jobless claims fell to 793,000 last week in a modest sign of labor market improvement. New data shows that 7.8 percent of Americans hold two or more jobs. The federal budget deficit is expected to top \$2 trillion this year, the second-highest since WWII. The Biden Administration pledged immediate action to address the global semiconductor shortage that has disruption to car manufacturing. A U.S. House committee on Thursday approved a proposal to give airlines another \$14 billion in payroll assistance as part of a broader COVID-19 relief package that is working its way through Congress.

Latin America is gearing up for a busy year of elections – one that has already started with Ecuador's February 7 presidential vote, which will go to a runoff in April. The ongoing pandemic, which by some measures of economic fallout and deaths per population has hit Latin America harder than any other part of the world, has exacerbated grievances about inequality, corruption, and poor public services that often drive political fortunes. A multitude of unknown election results in the coming year brings increased uncertainty amid already turbulent times. As discontent is channeled into the political process, or protest thereof, many countries are facing a period of increased instability and unrest.

The countries heading to the polls this year are a diverse group in terms of health of economies, politics, and democratic institutions. Some will elect new national leaders, while others will vote in midterms with important implications for the power of existing leaders. From Chile, generally considered a mature democracy, to Haiti, currently in the midst of a political crisis over its current president, each country has a unique domestic political landscape. But some trends may run across borders. International observers are watching nervously to see whether the seemingly global trend of failing democracy will be furthered in Latin America, while economists see the possible return of populism across Latin America a key source of risk to the battered regional economy.

#### South America

Overall, the South American nations heading for elections in 2021 are healthier democracies than most of those in Central America. But elections still promise to be contentious as countries grapple with major societal issues. Argentina and Ecuador have recently defaulted on national debts, political crisis in Peru has led the country to cycle through three presidents within a span of months, and Chile, Peru, and Ecuador all saw massive protest movements in 2019 and 2020. Significant uncertainty surrounds most election results. The presidential candidate pool for Peru has reached a record 22 people,

with no clear frontrunner. Chile will vote for not just a new president this year, but also for local officials and perhaps most importantly, delegates to the constitutional convention, which will draft a new constitution to submit for public ratification in 2022. For Argentina, midterm legislative elections will have important implications for the ability of President Alberto Fernandez to effectively govern. In Paraguay, local elections for mayors and councilmembers will provide an opportunity for parties to consolidate power ahead of the country's 2023 presidential vote.

After completing its February 7 vote, Ecuador is heading for runoff elections on April 11, after leftist economist Andrés Arauz drew the most votes but failed to secure enough for outright victory. With the two other candidates, conservative pro-business investor Guillermo Lasso and Indigenous environmental activist Yaku Peréz, virtually tying for the second-most votes, it remains uncertain who Arauz will face in April, and supporters of both Peréz and Lasso have taken to the streets while the vote remains uncalled. For whoever does go to runoffs, a third political figure will loom large: former populist president Rafael Correa, a divisive figure who continues to shape Ecuador's political landscape and backs Arauz. Deep political

divisions and a grim economic reality will ensure that whoever wins the presidency will face a tough job governing.

#### **Central America**

Concerns about the erosion of democracy are most focused on Central America. Nicaraguan President Daniel Ortega has long been a target of criticism for anti-democratic behavior – in the words of the US State Department's most recent statement on the country, "Ortega is driving Nicaragua towards dictatorship." Over the past year, Ortega's government passed new laws that pro-democracy activists say will effectively bar opposition candidates from running in the coming elections. In nearby El Salvador, President Navib Bukele has also been criticized for authoritarian tendencies, though on a very different scale from Ortega. Bukele has only been in office since 2019, and midterm elections will test his New Ideas party, possibly tightening his control of the government. In Honduras, the memory of 2017 elections remain a source of discontent, when allegations of widespread fraud resulted in weeks of protests and strikes. Current President Juan Orlando Hernández has said he will not run again, but his party, the National Party of Honduras (PNH), may be in a strong position to retain political control.

In Mexico, major midterm elections will test the popularity of President Andrés Manuel López Obrador and his ruling Morena party, in a multitude of gubernatorial, mayoral, state legislature and national legislature races, determining the makeup of the national legislature and with it, Morena's ability to enact constitutional changes. The outcome will be critical for the nation's energy sector, potentially giving Lopez Obrador the power to restore the dominance of Pemex and CFE, moving the country further away from a liberalized energy market. Opinion polls show high ratings for Lopez Obrador, with the pandemic seeming to have little negative impact on his popularity.

Haiti will also hold elections this year – but a political crisis already underway has cast doubt on how polls will proceed. President Jovenel Moïse is seeking to stay in office for another year amid widespread anti-government protests calling for him to step down. Moïse was elected for a five-year term in 2016 but did not take office until 2017, which he believes means his term should end on February 7, 2022 – a stance backed by the UN, US, and Organization of American States (OAS). Opposition figures,


protestors, and many domestic legal experts disagree, saying his term was up on February 7, 2021. Mass protests over the last weekend were met with a crackdown that only added to opposition and international grievances, while Moïse contends that the crackdown was in response to a coup attempt against him. The term dispute comes amid wider crisis in Haiti, which, along with a continued dire economic situation, faces heightened levels of gang violence and kidnappings. Allegations that Moïse's government has aligned itself with violent gangs adds another reason for protest. Along with the coming September presidential election, a referendum vote on expanded constitutional powers for the President will be held in April. Both elections are already plagued by accusations of illegitimacy and rigged voting, with opposition candidates vowing to boycott. As a dire security situation and economic downturn persist, there is no foreseeable end to unrest in the country.

As of 2100 hours US EDT on February 11, 2021




# **Confirmed Cases (New)**




